- Form Collection commenced: Thursday 2nd October 2025.

- Closing date for submission of completed forms: Monday 6th October, 2025
- Screening of candidates: Wednesday, 8th October, 2025.
- Release of names of successful candidates Thursday 9th October, 2025
- Candidates complaints should be directed to the committee's official emails within 24hrs of the release of the names.
- Final list of successful candidates shall be published on the CEC website on Friday 10th October, 2025.
- Election Day Tuesday 11th November, 2025.(Tentative)

GUIDELINES FOR THE ELECTION OF GLOBAL EXECUTIVE COUNCIL

In accordance with Part III, Section 11.1(i-xx) and transitional provisions Part IV, Section 14.0 (iv & v), the following guidelines shall be applicable:

1. All active financial members of any branch shall be qualified to aspire for nomination as a candidate.
2. A candidate shall be eligible for election as an officer of the Global Executive Council if he/she:
 - a. is a registered member of an existing Branch of the Association
 - b. Have a record of good behaviour and unflinching commitment to the affairs of the Association
 - c. has paid, his/her, Annual Dues, as and when due, for January to October 2025;
 - d. is a man/woman of proven integrity, organizational experience and demonstrable capacity to serve without expecting or having consideration for pecuniary rewards and/or remuneration;
 - e. has served or is serving as an officer at his/her Branch or any of its organs or Committees;
 - f. has attended/participated in the 2024 Annual Global Conventions.
 - g. is nominated by his/her Branch as evidenced by the endorsement of his/her Nomination Form by his/her Branch Chairman and Branch Secretary.
 - h. the nomination of a candidate for election to the office of President, First Vice President, Second Vice President, General Secretary and Assistant General Secretary shall be further endorsed by the Branch Chairmen and Secretaries 3 of the functional Branches of the Association apart from his/her branch.

i. the nomination of candidates for election to all other offices different from the ones mentioned in (g) above shall be further endorsed by the Chairmen and Secretaries of two (2) functional Branches of the Association other than his/her registered branch.

j. each candidate seeking election shall obtain, complete and submit a Nomination Form in accordance with the election guidelines that is released by the Central Electoral Committee, however, candidates who neglect or fail to complete a Nomination Form appropriately or submit the Form before the close of the nomination period shall be disqualified by the Central Electoral Committee.

Also,

1. all elections, shall be by electronic voting and any candidate who scores a simple majority of valid votes cast shall be declared elected.

2. competent consultant will be engaged with a robust electronic platform

3. proportional delegates will be employed using 20% of financial member to the nearest whole number.

4. Such delegates nomination/election shall be carried out with utmost transparency and in the presence of a member(s) of the CEC or it's consultant.

5. The delegates from each branch shall be the ones to vote for the candidates on the day of the election.

6. Where there's a tie vote for candidates, such candidates will have a re-run immediately.
